## Provincial Health Services Authority – Women's Innovation Fund Guidelines 2018/19

Amount available: \$75,000 per fiscal year, for 2018/19 and 2019/20

The Provincial Health Services Authority (PHSA) is seeking proposals for innovative, short-term projects which focus on promoting the health of <u>indigenous women</u> living with or at risk of HIV/HCV.

#### **Guidelines:**

- Funds are for fiscal year 2018/2019 and 2019/20
- Preference will be given to those demonstrating innovative solutions
  - o In relation to this funding, innovative means an idea, service, practice or product, new or applied in a new way, which creates a change and/or improvement in quality of care
  - o Funds should be used to help an organization build the provincial scope of their work
- Funding will be awarded by October 15, 2018
- Funding may be awarded to one or a combination of community organizations
  - o Partnership and collaboration across community organizations and PHSA is encouraged
  - Partnership with Oak Tree Clinic should be demonstrated
- Evaluation will be a requirement; it is mandatory to document outcomes and key learnings and share with PHSA
  - o PHSA will work with successful proponent to create an evaluation plan with indicators
  - The successful proponent will be required to report quarterly on financials and indicators to PHSA
- Successful proponent(s) will be required to sign a contract for services outlined in the application
- Successful proponent(s) will be invited to participate in PHSA's Collective Impact Network

## **Applications**

- Applications must be submitted to lauren.allan@bccdc.ca by September 14, 2018
- Applications must be no longer than two pages with 12pt, Times New Roman font, single spaced with one inch margins
- Applications must be submitted using the following format (template to be provided):
  - Agency name
  - Requested funding amount
  - Description of project
    - Be sure to demonstrate an ability to build provincial scope, a focus on indigenous women, innovation, meaningful inclusion of people with lived experience, collaboration, and a clear plan for working with Oak Tree clinic (including how Oak Tree has been engaged in the process)
  - Implementation strategy
  - o Evaluation plan
  - Budget (not included in two page limit)
    - Fiscal year 2018/19
    - Fiscal year 2019/20
  - Most recent Financial Statements

## **Evaluation of Applications**

- BC Centre for Disease Control, BC Women's Hospital and PHSA Indigenous Health will form an evaluation committee to review proposals
- All applications are considered confidential
- Applications will be evaluated using a pre-specified criteria and grading rubric (see page 3)
- PHSA will award funds to the successful agency by October 15, 2018
- PHSA may ask the successful agency to adjust their budget and/or deliverables as needed
